

**BYLAW NO. 454-96**  
**OF THE TOWN OF CORONATION**  
**IN THE PROVINCE OF ALBERTA**

This Bylaw being Bylaw No. 454-96 of the Town of Coronation, in the Province of Alberta for the purpose of regulating the times after which a child shall not be in a public place at night without a guardian present.

WHEREAS, Part 2, Division 1, Section 7 of the Municipal Government Act, being Chapter M-26.1 of the Revised Statutes of Alberta, 1994, and amendments thereto, authorizes a Council to pass a Bylaw regulating the time which a child shall not be in a public place at night without a guardian present; and

WHEREAS, the Council of the Town of Coronation is of the view that it would be in the best interests of the residents of the Town of Coronation that a Bylaw be passed to regulate the time after which a child shall not be in a public place at night without a guardian present.

NOW THEREFORE, the Council of the Town of Coronation duly assembled enacts as follows.

This Bylaw may be cited as the "Curfew Bylaw".

**1. DEFINITIONS**

- a) **"Child"** means a child male or female fifteen (15) years of age or under.
- b) **"Council"** means the Council of the Town of Coronation.
- c) **"Guardian"** means a person who is eighteen (18) years of age or older and is responsible for a child.
- d) **"Administrator"** means the Municipal Administrator of the Town of Coronation.
- e) **"Peace Officer"** means
  - i) a member of the Royal Canadian Mounted Police;
  - ii) a Special Constable;
  - iii) a Bylaw Enforcement Officer.
- f) **"Town"** means the Town of Coronation.
- g) **"Designated site"** means a police station

**2. CONTROL**

- 2.1 No child shall be in a public place within the corporate limits of the Town of Coronation after the hour of 11:00 p.m. on any day and before the hour of 6:00 a.m. on the following day without a guardian present.
- 2.2 Any child to whom this Bylaw applies who is found in a public place without a guardian present after the hour of 11:00 p.m. on any day and before the hour of 6:00 a.m. on the day following may either be taken to his/her home or a designated site by the Peace Officer.

**3. PENALTIES**

- 3.1 Any parent or guardian who permits his/her child or child into his/her care to contravene this Bylaw is guilty of an offence and liable upon summary conviction to a fine that is outlined in Schedule "A".
- 3.2 A child who is identified in a public place within the corporate limits of the Town of Coronation during the times identified in Section 2.1 of this Bylaw may have his/her rights to access to specified Town-owned facilities privileges suspended as designated by Council.


**4. EFFECTIVE DATES**


- 4.1 Bylaw 001-57 is hereby repealed.
